Barry is a recognised specialist in Regulatory and Health & Safety work. He regularly advises and represents those charged with offences arising from fatal road traffic accidents, and in relation to deaths at sea and in aviation. He is experienced in the conduct of complex and high-profile Fatal Accident Inquiries, notably those arising from investigations by the MAIB and AAIB, having acted for the Civil Aviation Authority and frequently for the owners and operators of commercial vessels.

His principal specialism is in the defence of charges under the Health and Safety at Work etc Act 1974 and related Regulations. He frequently acts in appeals against enforcement notices. He is recommended in both Legal 500 and Chambers in Health & Safety. He is described as having "in-depth knowledge of health and safety law" (Legal 500) and "a true specialist in Health and safety," having been instructed in many of the significant health and safety cases in Scotland

in the past decade including Scottish Power Generation Ltd (in the Court of Appeal on sentencing guidelines) and Chevron North Sea Ltd (in the UK Supreme Court on the scope of Enforcement Notice Appeals) . He acts for major clients in the engineering, oil & gas, rail, aviation, maritime, construction, transport and retail industries, as well as for HSE.
