Profile

Dominic practises in the fields of public, administrative and regulatory law; public and fatal accident inquiries; health and safety; and reparation. He called to the Bar in 2020, having qualified as a solicitor in 2012 and as a solicitor advocate in 2016.

He has appeared in courts at all levels, including the UK Supreme Court, and has particular experience of judicial review and other proceedings which raise public law issues. He is regularly instructed for opinions on matters of statutory interpretation; human rights; public law as it relates to the protection of children; and devolution issues. He has been a Standing Junior Counsel to the Scottish Government since 2020 and the Second Standing Junior since 2024.

Dominic also has experience across the range of legal processes following accidents at work, including enforcement notice appeals; fatal accident inquiries; and reparation actions. He authored the reissue of the Stair Memorial Encyclopaedia volume on 'Health and Safety at Work'. He was instructed in the trilogy of Lord Advocate's References on the law of corroboration in 2023 and 2024 and intervened on behalf of a charity in a criminal appeal to the Supreme Court.

Dominic has represented professionals and regulators in fitness to practise proceedings and has advised on matters of professional conduct/discipline. He was instructed for a core participant in an ongoing Scottish public inquiry.

Dominic has lectured/tutored at a number of universities and has had various articles and book chapters published. He was a Law Reporter for Session Cases from 2017 to 2022 and is a member of the Editorial Board to the Stair Memorial Encyclopaedia.
