## Practice

Gavin Anderson specialises in white collar crime, Inquiries and regulatory cases. He appears regularly in the High Court of Justiciary, Sheriff Courts and disciplinary tribunals throughout Scotland. He is regularly instructed to defend in health & safety prosecutions involving fatality or serious injury, road traffic offences and environmental crimes involving pollution and waste management, as well as other forms of commercial crime, including fraud, money laundering, bankruptcy, licensing, financial services and company director offences. He has acted for accused persons, partnerships and companies facing prosecution as well as regulators including the Financial Conduct Authority, local authorities and police forces in the exercise of their enforcement functions.

Mr Anderson served as Crown Counsel from 2021 to 2024. He was Lead Crown Counsel for the Scottish Fatalities Investigation Unit and the Health and Safety Investigation Unit where he oversaw the conduct of many complex deaths investigations and health and safety prosecutions. He also worked extensively with the Road Traffic Fatalities Investigation Unit and prosecuted a number of death by dangerous driving cases in the High Court of Justiciary.

As Crown Counsel, Mr Anderson chaired multi-agency meetings following serious incidents, where he oversaw investigative strategy and enforcement action. He is well-placed to advise on internal corporate investigations or compliance with external regulatory action.

Mr Anderson has been instructed in a number of the most high profile and significant public and fatal accident inquiries to take place in Scotland over recent years.

Mr Anderson has a wealth of experience defending criminal proceedings arising out of fatal accidents in the workplace. He regularly acts for individuals, companies, partnerships and public bodies facing prosecution.

Mr Anderson has extensive experience in cases of alleged fraud, money laundering, bankruptcy, licensing, financial services, data protection and company director offences. He has provided advice in relation to bribery both nationally and internationally.

He has acted for both accused persons and companies, as well as financial institutions and regulators concerning bribery and large-scale frauds, including boiler-room fraud, carousel fraud and Ponzi schemes.

The very serious nature of the allegations made against commercial clients in such cases means that often Mr Anderson's work in this field is advisory at the investigative stage, with many contentious matters remaining out of the public domain.
